5. Terms and Conditions of Credit

1. **Payment Terms:** Payment is due 30 (thirty) days from statement date. Forge reserves the right to vary or withdraw terms at its discretion.
2. **Domicilium:** The Applicant chooses its physical and email address as domicilium for all legal purposes and service of process.
3. **Jurisdiction:** Forge may institute legal action in any Magistrate's Court having jurisdiction, irrespective of the claim value.
4. **No Set-off:** No dispute or query shall entitle the Applicant to withhold payment or apply any set-off.
5. **Credit Limit:** Forge may allocate a credit limit and withhold supply if exceeded or if the account is overdue.
6. **Acceleration:** On default, the full outstanding balance becomes immediately due and payable.
7. **Ownership:** All goods remain Forge property until paid in full. Risk passes on delivery.
8. **Suspension:** Forge may suspend supply without notice if the account is overdue.
9. **References:** The Applicant consents to Forge contacting trade references and credit bureaus for credit assessment.
10. **Electronic Communication:** Orders and approvals transmitted via email are legally binding and enforceable.
11. **Amendments:** No representations or amendments shall be binding unless confirmed in writing by Forge.
12. **Suretyship:** The signatory binds themselves as surety and co-principal debtor for the obligations of the Applicant.
13. **Legal Costs:** The Applicant and surety shall be liable for legal costs on an attorney and client scale plus collection commission.
14. **Dormancy:** If no purchases occur for three consecutive months, the credit facility may be withdrawn without notice.
